



ARE YOU READY FOR GOVERNMENT CONTRACTING?

Answer the questions below before your first counseling session. This will help both you and your counselor assess your contracting readiness.

1. Do you have a solid business plan created?
2. Has your business been registered for at least 12 months?
3. Is your business legally registered in the state of Maryland? If registered in another state, but doing business in Maryland—are you registered as a “Foreign Business” entity? 4. Is your company in good standing with the State of Maryland? For additional information search here <https://businessexpress.maryland.gov/>
5. Have you generated a profit from your business? If yes, was it done through commercial (public or retail sale), private (person or individual) or government (federal agency, local or state agency/department)?

Business Operations

- 5a What do you project your annual revenue to be this year?
- 5b What will your Net (pre-tax) Profit be?
- 5c What goods and/or services will you be selling?
- 5d What resources will you need to achieve your business operation projections?
6. Have you been/are currently a subcontractor or prime on any State or Federal contracts?
7. For federal contracting: Is your company registered in the System for Award Management (SAM)? <https://sam.gov/content/home>
 - a Do you have a Unique Entity Identification Number (UEI)?

- b Do you have a CAGE CODE number?
 - c If yes, have you validated your SAM account within the last 12 months?
8. For MD State and Local Level contracting: Is your company registered on the online contracting portal- “eMaryland Marketplace Advantage” **eMMA**? To check [CLICK HERE](#) or go to <https://emma.maryland.gov/page.aspx/en/usr/login?ReturnUrl=%2fpage.aspx%2fen%2fbuy%2fhomepage>
9. Does your company have any past performance with the local, state, or federal government? If so, with whom?
10. Has your company been awarded any Government Wide Acquisition Contracts (GWACs)? ex. GSA MAS contracts (IT, Professional Services, 8a-Stars III, Vets 2, Polaris) or other Federal Agency GWACs (ex. NIH-NITAAC)?
11. Does your company have a Capabilities Statement, Web site, or other marketing materials?
12. Does your company have any local, state, or federal government certifications? Some examples of certifications are: Small Business Administration (Women Owned Small Business, 8(a), HUBZone, Small Disadvantaged Business or Veteran Owned Small Business) or MD’s Small Business Reserve (SBR), Minority Business Enterprise (MBE) etc.?
13. Are you familiar with the points of contacts at agencies who deal with Small Businesses? Ex. Federal Agencies’ Office of Small and Disadvantaged Business Utilization (OSDBUs) or state of MD-Governor’s Office of Small, Minority and Women’s Business Affairs. <https://gomdsmallbiz.maryland.gov/Pages/About-Us.aspx>
14. Is your company registered on any state or federal procurement bid boards? MD PTAC website provides information on these, [CLICK HERE](#) or visit <https://www.mdptac.org/countycontracting>. If so, which agency are you registered with, and are you viewing them daily?
